2021 Annual Stockholders' Meeting**

Frequently Asked Questions (FAQs)

ASM Quick Facts

1. *When and where will the 2021 Annual Stockholders' Meeting of Nat Re be held?*

Date: June 23, 2021 (Wednesday)

Time: 3:30 p.m.

Place: will be conducted virtually through <https://www.nat-re.com/investor-relations/annual-stockholders-meeting/>

2. *Why will the Annual Stockholders' Meeting be held virtually?*

Due to health and safety concerns brought about by the COVID-19 pandemic, and in compliance with quarantine guidelines, the Company decided to hold again this meeting virtually to allow stockholders to participate and vote remotely in the safety of their homes. This virtual meeting is authorized by and will be held in accordance with existing laws and regulations of the Securities & Exchange Commission.

3. *When is the record date for stockholders entitled to vote and to participate?*

Record date is as of close of business on May 10, 2021.

Registration

4. *Who can register?*

Stockholders of record of National Reinsurance Corporation of the Philippines as of close of business on **May 10, 2021** may register. Once verified, they will receive an email confirming their registration for the virtual Annual Stockholders' Meeting and instructions on how to vote.

5. *When can I register?*

The registration portal is open from **May 24, 2021** to **June 16, 2021**.

6. *Where do I register?*

7. *What information do I have to provide to complete the registration? Do I have to submit documents?*

For verification and validation purposes, we will require your full name and other information / requirements below:

A. For Individual Stockholders

1. Copy of valid government-issued ID of stockholder/proxy
2. If appointing a proxy, copy of proxy form duly signed by stockholder
3. Active email address and contact number of stockholder or proxy

B. For Corporate Stockholders

1. Secretary's Certification of Board Resolution appointing and authorizing proxy to participate in the annual stockholders' meeting
2. Copy of proxy form duly signed by authorized representative(s)
3. Valid government-issued ID of the authorized representative
4. Active email address and contact number of authorized representative

C. For Stockholders with shares under PCD participant/broker's account or "scripless shares"

1. Certification from broker as to the stockholder's shareholding
2. Valid government-issued ID of stockholder
3. If appointing a proxy, copy of proxy form duly signed by stockholder
4. Valid email address and contact number of stockholder or proxy

8. *I do not have an email address. Can I still register for the meeting?*

No. You will need to create an email address since the links for registration, voting and livestream will be sent to your registered and official email address.

9. *How do I know if my registration is successful?*

You will receive an email confirmation that you can join Nat Re's virtual Annual Stockholders' Meeting, and the related link to the Zoom Webinar will be provided.

10. *How long will it take before I receive the email of successful registration?*

You will be notified of successful registration within 3 working days from completing the registration. Stockholders are encouraged to submit complete and accurate information to avoid delay in the validation of your registration.

11. *I do not have all the information required. How do I proceed?*

Certain information is mandatory so we can proceed with verification and validation. This is to ensure that only stockholders entitled to participate and to vote are given access to the voting portal and the livestream.

Required fields are marked with a red asterisk (*). You must fill this up with the required information in order to complete your registration.

As a reminder, please make sure that you have selected the correct type/category of stockholder at the beginning of your registration to ensure that the requirements enumerated are applicable to you.

12. *Will I be informed if I am missing certain requirements?*

Yes. You will be notified of any lacking requirement by the Compliance Office via email within 3 days from registering online. You will then have to submit the remaining requirements by responding to that email.

After verification, you will be notified of successful registration within 3 days from sending the remaining documents via email.

13. *For Joint Shareholders, or those owning shares with other individual(s), do we all have to register?*

No. Joint owners need only to appoint an authorized representative among themselves who will be the one to register and participate at the virtual meeting. We will require though the contact details of all stockholders, plus the following documents:

- a. Proof of authority of stockholder voting the shares signed by the other registered stockholders (need *not* be notarized)
- b. Copy of valid Government IDs of all registered stockholders
- c. Email address and contact number of the authorized representative

14. *What are the requirements for corporate stockholders?*

For online registration, the corporation must provide the name of its authorized representative or proxy for the meeting plus the following documents:

- a. Secretary's Certification of Board Resolution appointing and authorizing proxy to participate in the ASM
- b. Copy of proxy form duly signed by authorized representative(s)
- c. Valid government-issued ID of the authorized representative
- d. Active email address and contact number of authorized representative

15. *I own shares through a broker, can I participate in the Annual Stockholders' Meeting?*

Yes, your broker can vote your shares, or you may also personally register, vote, and watch the livestream.

To complete your registration, you must submit the following:

- a. Certification from broker as to the number of shares owned by stockholder
- b. Valid government ID of the stockholder under a broker's account
- c. If appointing a proxy, copy of proxy form duly signed by the stockholder under Broker's Account

16. *Can I appoint the Chairman of the Meeting or other members of the Board of Directors as my proxy?*

Yes, you may appoint the Chairman of the Meeting or other directors as your proxy.

For you to appoint the Chairman of the Meeting or a Director of Nat Re, you must submit a fully accomplished proxy form appointing the Chairman of the Meeting or the director as your proxy for the meeting.

17. *Can I register through means other than <https://www.nat-re.com/investor-relations/annual-stockholders-meeting/>?*

You can only register for the meeting through <https://www.nat-re.com/investor-relations/annual-stockholders-meeting/asm-register/> as you will be required to upload documents for identity verification.

18. *What if I cannot personally register and/or participate in the virtual meeting? Can I appoint a proxy?*

If you are unable to register and/or participate in the virtual meeting, you may still participate and vote through a proxy. Your proxy will also be sent the link to the livestream of the Annual Stockholders' Meeting.

If you wish to appoint a proxy, please email the **accomplished proxy form** to asm@nat-re.com no later than **5 pm on June 11, 2021 (Friday)**.

19. *What if I want to appoint a proxy but I do not know anyone who can participate on my behalf?*

You may appoint the Chairman of the Meeting as your proxy. For you to appoint the Chairman of the Meeting, you must submit through email to asm@nat-re.com a fully accomplished proxy form appointing the Chairman of the Meeting as your proxy for the meeting.

20. *I submitted my proxy form online. Do I still need to submit the original to the Corporate Secretary?*

We may require submission of the original proxy form if the emailed copy is not clear, or if the signature cannot be verified.

21. *Where do I vote?*

Voting can be done in absentia via the **Nat Re's Online Voting Facility**, the link of which will be emailed to successfully registered stockholders, or you can also **vote by proxy** by sending through email your completed proxy form to asm@nat-re.com.

22. *When can I vote?*

A successfully registered shareholder can cast his/her vote starting **8:00 a.m. on May 24** until **5:00 p.m. on June 16, 2021 (Friday)** through the voting portal.

23. *How can I vote online?*

Once successfully registered, you will receive an email on the voting instructions and related link to the Online Voting Facility. Once you have accessed the voting portal, you will be able to cast your vote on each agenda item. Please review your entries and once final, proceed to submit the same by clicking the "Submit" button.

24. *Can I still change my votes on the voting portal after submitting them?*

No. Once submitted, you can no longer modify your votes. However, if the stockholder also executed a proxy vote while at the same time casting his vote through the online voting facility, the vote through proxy shall prevail.

25. *I do not want to personally cast my votes through the voting portal but wish to participate in the livestream. Can I appoint the Chairman of the Meeting or other members of the Board of Directors as my proxy?*

Yes, you may appoint the Chairman of the Meeting or other directors. For you to appoint the Chairman or a Director of Nat Re, you must submit a fully accomplished proxy form appointing the Chairman of the Meeting or the director as your proxy for the meeting.

26. *What happens to my votes if I appoint the Chairman of the Meeting or any Director as my proxy?*

All your votes will be automatically counted in favor of all the agenda items you have specifically approved, but if you did not indicate any specific vote, all will be counted in favor of the agenda items for approval.

27. *Can I pre-cast my votes and not use the voting portal?*

Yes, but only if you are appointing a proxy for the meeting. During registration, you may submit a duly accomplished proxy form containing your votes to specific items in the agenda.

28. *I do not want to vote but I still want to join the livestream meeting. What should I do?*

You may click on the registration link provided in the confirmation email to join the livestream meeting.

29. *I have several stock certificates of Nat Re. Do I have to register multiple times based on the count of stock certificates on hand?*

No. You will be allowed to register once, only one email address per Stockholder, regardless of the number of stock certificates issued. In the voting system, total outstanding shares issued will be reflected and voted as you have directed.

30. *I cannot find my Registration Confirmation Email. How can I retrieve it?*

You may email us at asm@nat-re.com and we will resend the Registration ConfirmationEmail.

31. *How will Nat Re ensure that my votes are properly counted?*

The Office of the Corporate Secretary and our Stock Transfer Agent - RCBC will count and tabulate votes cast through the Online Voting Facility and through proxy votes and announce the results during the meeting. The Company also engaged R.G. Manabat & Co. (KPMG Phils.) as an independent third party to further validate the voting results.

Quorum

32. *Will I be counted as part of the quorum?*

Yes, stockholders who will participate through remote communication or *in absentia* shall be deemed present for purposes of quorum for the meeting.

33. *Will I be counted for quorum even if I don't vote?*

Yes, once you have successfully registered for the meeting, you will be counted as part of the quorum.

34. *Will I be counted for quorum purposes even if I don't join the livestream meeting?*

No, registration is required in order to join the meeting by remote communication. Only those joining by remote communication are deemed present.

Joining the Livestream Meeting

35. *Who can watch and join the livestreaming?*

Stockholders of record as of May 10, 2021, who successfully registered for the Annual Stockholders' Meeting at <https://www.nat-re.com/investor-relations/annual-stockholders-meeting/> upon proper verification by the Company will be provided a link to join the livestreaming of the 2020 Annual Stockholders' Meeting.

36. *Can I share my livestream link?*

No, your livestream link is unique to you and only one person at a time may access the livestream through the link provided.

37. *Can I ask questions during the livestreaming?*

We encourage our stockholders to email their questions or comments before, during, or after the annual stockholders' meeting with the subject "ASM 2021 Feedback" to asm@nat-re.com.

Questions/comments received during the meeting but are unread/unanswered due to time constraints will be answered separately by the Company through email.

38. *Can I record the meeting?*

No. The Company will however maintain a video recording of the proceedings, available to stockholders upon request, in accordance with existing regulations.

39. *I can't find the email containing my link to the livestream. How can I retrieve it?*
